The Fund will typically invest in 40-80 companies that the Manager has identified through their bottom-up fundamental analysis. The Fund is not constructed to replicate the companies in an index. Instead, the Manager seeks to create a high conviction portfolio of high quality companies with exposure to emerging markets whose sustainable long-term growth rates may be underestimated by the market.




